Project Summary (1000)

The RNC, as one of the foremost organizations on transitional justice (TJ), has worked in Burundi since 2005, conducting multiple expert missions, organizing various technical workshops, and implementing security system reform (and presently leading country-wide police census). The RNC works in close partnership with the UN, civil society, and other key partners.

In this program the RNC will help develop the capacity of the proposed Truth Commission (TRC), government, civil society, media, and UN to strengthen TJ initiatives. This would also include providing technical expertise to the UN Integrated Office (BINUB), UNDP, and the OHCHR. In addition, the RNC will advocate for victims' organizations and support effective SSR/vetting initiatives. All these activities will help strengthen transitional processes, the rule of law, and peacebuilding in Burundi - providing increased opportunities for the consolidation of democratic gains since the 2005 legislative and presidential elections.

Gender considerations (500):

Gender considerations have been taken into account in the project design:

The RNC's gender team reviews all aspects of the Burundi country program ensuring effective mainstreaming. The RNC has developed specialized French language gender training modules and handbooks on TJ issues that will be utilized in this program. The RNC is working directly with women's groups such as Dushifem to provide technical training on gender and TJ issues in order to ensure the full participation of these organizations in policy and program development in Burundi.

The conflict in Burundi produced a large number of vulnerable groups: children and women have been subjected to a pattern of violence which includes conscription, forced labor, sexual violence, etc. It has also caused massive displacement, whether internally (IDPs) or outside the country. The RNC will work closely with victims and human rights groups for capacity development, training, and advocacy around various forms of redress and empowerment, and will raise awareness about victims' rights.

Against the backdrop of decades of violent conflict characterized by human rights abuse, the implementation of accountability measures to come to terms with the past will help lay the foundation of sustainable democratization. In fact, UN Resolution 1606 (2005) identified two TJ mechanisms, namely a Truth and Reconciliation Commission and a Special Tribunal as pillars to support peacebuilding, democratization and restoration of the rule of law.

Since its earliest involvement in Burundi the RNC has identified the great need for technical assistance, comparative information sharing about truth commissions and hybrid tribunals, and capacity building opportunities. Another key challenge in Burundi is the proper sequencing and management of these various processes. Lastly, institutional reform is a prerequisite for a return to civic trust for the rule of law. The RNC has been very active in all three of these fields and can build on strong partnerships in the country.
