

1. Implementin Organization Name: Centre for Research and Action for Sustainable Development and Fulfilment of Societies (CRADDES NGO).

2. Project Title: Prevention of consequences of unwanted pregnancies in schools and promotion of adolescent and youth sexual and reproductive health education in Abomey-Calavi.

3. Project Executive Summary:

The phenomenon of pregnancy in schools is very particular in Benin, because it is often unwanted and with consequences on the lives of porters, authors, parents and the whole education system. Then this project will contribute to prevent involuntary pregnancy and its consequences through quality sexual and reproductive health and family planning education in Benin among young girls and boys (aged 10-24) with some keys schools and communities stakeholders involvement. Also, through this project we will strengthen services on the ground to ensure that adolescents and youth have the right to and the ability to access voluntary family planning. By end of the project 1100 direct beneficiaries will be impacted. For this project, the amount requested from the is US\$. The project will be implemented in Abomey-Calavi. The project will cover one public's secondary school and communities of this rural town. This area is chosen because Adolescents and Youth has a serious sexual and reproductive issues. The project duration is 2 months (From November to December 2018).

4. Brief description of the context :

Pregnancy is normally a happy event for the one who carries it because it makes her a future mother and to her author a future father. But in Abomey-Calavi, the phenomenon of pregnancy in schools is very particular, because it is often unwanted and with consequences on the lives of porters, authors, parents and the whole education system. When a young student is pregnant, she is a real problem for herself, for her parents, a handicap for her studies and her personal development. Thus the consequences of this phenomenon are on several levels: the health plan, the moral plan and the school plan.

5. Project Objective: Contribute to prevent the consequences of unwanted pregnancies in school and promote adolescent and youth sexual and reproductive health education in Abomey-Calavi.

6. Expected Results :

Generally, around 1100 beneficiaries will be positively impacted by the end of the project such as:

- ✓ 10 family planning services providers trained on sexual and reproductive health of adolescents and youth rights have the appropriate skills and knowledge to assist better beneficiaries.
- ✓ Adolescents and Youth have the right to and the ability to access voluntary family planning services.
- ✓ 20 parents, school stakeholders, religious and community leaders are strengthened and play better roles and responsibilities in term of AYSRH.
- ✓ 1000 adolescents and youth are empowered on quality AYSRH education through a communication for behavior change.
- ✓ Local authorities of Abomey-Calavi commit to budget and prioritize the AYSRH in local policies.
- ✓ 12 peer educators are trained among students and teachers to ensure the sustainability of awareness-raising, counselling and referrals to health centers during and after the project.

7. Project duration: From 1st November 2018 to 30th of December 2018

8. Location : The project will cover one public's secondary school and communities of Abomey-Calavi in Benin. This area is chosen because Adolescents and Youth has a serious sexual and reproductive issues.

9. Project Team : The Project will be implemented by 1 person on a voluntary basis. This person has a Master degree. He has great experience in project facilitation. He will be supported by CRADDES team.
